PageSpinner is a semi-WYSIWYG HTML Editor for Macintosh. It supports both HTML 2.0, parts of HTML 3.0 plus several Netscape extensions and is useful for both the beginner and the more advanced web writer. It gives you quick access to often used formatting and also supports AppleGuide and an HTML Assistant that helps you create your HTML pages.
