

What if I have trouble putting Creative Writer or Fine Artist on my computer?

• Sometimes programs that start whenever you turn on your Macintosh can cause problems when you try to set up Creative Writer or Fine Artist. Try removing these programs from your System folder before you set up Creative Writer or Fine Artist. Follow the steps for removing virus detectors near the beginning of this booklet. After you've set up Creative Writer or Fine Artist, you can put them back.

If you have System 7, try holding down the Shift key when you turn on your computer.

What if my document doesn't print?


- Make sure your printer is turned on. Plug the printer into your computer and into a power outlet. Turn on the printer's power switch. If you need more help, see your printer's manual.
- Make sure there is paper in the printer. Make sure the paper isn't jammed in the printer.
- Check your printer cable to see if there are any loose connections to either the computer or printer.
- Make sure the printer is "on line." Most printers have an
 On Line button with a light next to it. If the light is not on, press the On Line
 button. If your printer doesn't have an On Line button or light,
 check your printer's manual for more information.
 - Make sure your computer is correctly set up to print to your printer. For more information, see your printer's manual. If you still can't print, call your printer manufacturer.

What if the pictures or text are cut off when I print?

• If you're using a dot matrix printer (for example, an ImageWriter®), make sure the paper is lined up correctly. For more information, see your printer's manual.

• Most laser or ink jet printers (for example, a StyleWriter®) cannot print to the edge of the page. You need to leave a minimum margin area. For more information, see your printer's manual.

- If you're using Fine Artist, don't enlarge the picture before you print. This is one of the questions McZee asks when you print.
- If the printout is cut off at the bottom, your printer may not have enough memory to print all of your picture. Simplify your document. Try removing some of the pictures or stickers.



Can I open a document from another program in Creative Writer or Fine Artist?

- Yes! In Creative Writer, you can open a Microsoft Word or Microsoft Works document, or any other document saved as a Text file.
 Most word processing programs let you save a document as a Text file.
- In Fine Artist, you can open any PICT or MacPaint® document.

Can I open a Creative Writer or Fine Artist document in another program?

 Yes! If you have Creative Writer, you can save the document as a Text file, then open it in another word processing program. When you save a document as a Text file, you keep only text and lose most formatting.

To preserve more formatting, you can buy a special utility that saves your document with words, pictures, and some formatting. For more information, call DataViz Inc. at (203) 268-0030. Customers outside the United States may contact local distributors and dealers for information on DataViz Inc. products.

- If you have Fine Artist, you can save your document as a PICT file and then open it in another paint program.
- For information on saving documents as Text or PICT files, see the next section.
- To move files from the Mac to a PC, use these file name extensions: .MAX (Creative Writer) or .MAG (Fine Artist).



Can I change Creative Writer or Fine Artist settings?

Once you've started Creative Writer or Fine Artist, you can change settings using the Control Room menu bar.

Questions...

What if I don't hear any sound?

 If you don't have a sound card, you won't hear any sound.

 Check the speaker volume. Make sure the sound card or mixer is turned up as well.

• Make sure the sound board and sound board software are installed correctly. The sound board may need to be pressed more securely into its slot.



- If you have both a sound board and special software that bypasses the sound board to play sounds through the computer's speaker, we suggest you remove or disable the special software (the computer's speaker driver).
- If you have a Media Vision[™] card (Pro Audio Spectrum), try updating the driver.

What if the sound plays but is distorted?

- The speaker volume may be set too high.
- The volume control for your sound board may be set too high.

To change the sound board settings, check the manuals that came with your sound board. You can usually change the volume using the sound board volume dial (found at the back of your computer) or by using a program that is often called a "mixer" (installed in the Windows Control Panel of the Main program group). 


